

## **Conneaut Lake Regional Police**

### **Weekly Police Blotter**

#### **Week of January 21, 2018**

##### **Sunday January 21**

At 2:07 a.m. officers were dispatched to a State Highway 285 residence, Sadsbury Township, for the report of a structure fire. Officers assisted responding fire departments at the scene and with traffic control.

##### **Monday January 22**

At 9:12 a.m. officers were dispatched to a Lakeside Drive residence, Sadsbury Twp., for the report of a deceased male. It was determined that the male passed away of natural causes.

At 11:23 a.m. officers were dispatched to a State Highway 18 business, Sadsbury Twp., for the report of an abandoned vehicle. The investigation is continuing.

At 5:37 p.m. officers were dispatched to a Water Street apartment, Conneaut Lake Borough, for the report of harassment. Investigation revealed that a known person entered the residence and an argument ensued. All parties were advised to avoid each other as neither party wished to press charges.

At 5:59 p.m. officers were dispatched to a State Street business, Conneaut Lake Borough, for the report of a fight in the parking lot. It was reported that a male and female exited a vehicle and the male was observed assaulting the female. A witness reported that the vehicle went west on State Street prior to officer arrival and officers were unable to locate the vehicle.

##### **Tuesday January 23**

At 1:15 p.m. officers were dispatched to a Choctaw Circle residence, Sadsbury Twp., for the report of theft. The caller reported a stolen dog by an ex-boyfriend. Investigation revealed that both parties had a vested monetary interest in the animal and were referred to civil court.

##### **Wednesday January 24**

At 10:00 a.m. officers were dispatched to Ferguson Allotments, Sadsbury Twp., for the report of an indecent sexual assault. Investigation is continuing.

At 10:15 a.m. officers were dispatched to Penn Lake Village, Sadsbury Twp., for the report of theft. Caller reported that an ex-landlord failed to return a television. The investigation was determined to be unfounded.

At 11:35 a.m. officers were dispatched to State Highway 285 near South Canal Road, Sadsbury Twp., for the report of a motor vehicle crash. Investigation revealed that two vehicles were westbound when the 80 year old male operator from Espyville attempted to pass a vehicle operated by a 28 year old Conneaut Lake female and lost control of the vehicle in the process. No injuries were reported and citations were filed.

At 12:16 p.m. officers were dispatched to a Conneaut Lake Road motel, Sadsbury Twp., for the report of a behavioral disorder. Officers repeatedly attempted contact with the 60 year old Conneaut Lake male subject. At approx. 3:30 p.m. officers received an additional call that the male attempted to leave the motel in a vehicle and was nearly struck by multiple vehicles on the highway. Officers located the male on State Highway 618 and the male was transported to Meadville Medical Center for an evaluation.

#### **Thursday January 25**

At 8:46 p.m. officers were dispatched to a Water Street business, Conneaut Lake Borough, for the report of fraud. It was reported that a patron presented possible counterfeit currency. The investigation is continuing.

#### **Friday January 26**

At 1:09 a.m. a patrol vehicle was struck by a deer on Brooks Road, Sadsbury Twp., causing damage to the vehicle and resulting in all airbags deploying. The officer was not injured.

At 8:22 p.m. officers were dispatched to State Highway 18, Sadsbury Twp., to assist Pa State Police in locating a vehicle involved in a hit and run crash at State Highway 18 and 618. Officers were unable to locate the vehicle.

#### **Saturday January 27**

At 1:58 a.m. officers located a suspicious vehicle at Firemen's Beach, Conneaut Lake Borough. The operator was identified and all was determined to be okay, however the subject was removed from the area in violation of borough ordinance regarding park use hours.

At 9:24 p.m. officers initiated a traffic stop at Water Street and 5<sup>th</sup> Street, Conneaut Lake Borough, and it was determined that the 32 year old Hartstown male operator was wanted out of Trumbull County Ohio. The male was taken into custody and lodged in the county jail awaiting extradition.

**Miscellaneous.** Officers responded to assist fire, EMS, and citizens on 6 occasions and answered 2 alarm calls. Patrol officers conducted 21 traffic stops resulting in 8 traffic citations being issued.
