

## **Conneaut Lake Regional Police**

### **Weekly Police Blotter**

#### **Week of February 4, 2018**

##### **Sunday February 4**

At 9:30 a.m. officers were dispatched to State Highway 285 and W. Townline Road, Sadsbury Township, to assist the Pa State Police with traffic control for a motor vehicle crash in E. Fallowfield Twp.

At 2:26 p.m. officers were dispatched to the intersection of Conneaut Lake Road and State Highway 18, Sadsbury Twp., for the report of debris in the roadway. It was determined that an unknown vehicle struck multiple roadway signs on a traffic island at the intersection causing the debris in the roadway.

At 10:06 p.m. officers were dispatched to Water Street and 4<sup>th</sup> Street, Conneaut Lake Borough, for the report of a motor vehicle crash. It was learned that a 18 year old Jamestown PA female was traveling east on Water and lost control of the vehicle striking a utility pole. There were no reported injuries.

##### **Monday February 5**

At 8:07 a.m. officers were dispatched to Conneaut Lake Middle School, Sadsbury Twp., for the report of a behavioral disorder. The incident was referred to the Conneaut School Resource Officer.

At 10:53 a.m. officers were dispatched to the 9800 block of US Highway 6, Sadsbury Twp., for the report of a motor vehicle crash. It was determined that an 18 year old Linesville female was east on US Hwy 6, lost control of the vehicle and left the roadway. The vehicle rolled over at least once. The operator sustained injury and was transported for medical care.

At 1:49 p.m. officers were dispatched to a State Street residence, Conneaut Lake Borough, for the report of a domestic argument. A father and son were involved in a heated argument.

At 6:04 p.m. officers were dispatched to Water Street Ext. and State Highway 285, Conneaut Lake Borough, for the report of a disabled motorist.

At 6:34 p.m. officers were dispatched to the 12000 block of State Highway 618, Sadsbury Twp., for the report of a burning complaint. The subjects burning were requested to extinguish the fire based on the noxious fumes and did so.

##### **Tuesday February 6**

At 7:53 a.m. officers were dispatched to the 11000 block of State Highway 285, Sadsbury Twp., for the report of a motor vehicle crash. It was determined that a 21 year old Conneaut Lake female was east on the highway and lost control of the vehicle. The vehicle left the roadway and struck a pasture fence. No injuries were reported.

At 7:11 p.m. officers were dispatched to Leach Road, Sadsbury Twp., for the report of a train blocking the roadway. Upon contact with the railway it was learned that a large tree had fallen across the railroad tracks stopping the train. The tree was removed a short time later and the roadway opened.

### **Wednesday February 7**

At 8:00 a.m. officers were dispatched to US Highway 6 and State Highway 618, Sadsbury Twp., for the report of a vehicle in the ditch. It was determined that a 27 year old Saegertown female lost control of the vehicle entering the roadside ditch. The vehicle was removed from the ditch without damage.

At 5:21 p.m. officers were dispatched to a W. Townline Road residence, Sadsbury Twp., for the report of a behavioral disorder. The male subject was transported to the hospital for assistance.

At 6:20 p.m. officers were dispatched to US Highway 322 and Stoney Point Road, Sadsbury Twp., for the report of a disabled motorist.

At 7:38 p.m. officers were dispatched to the 1100 block of State Street, Conneaut Lake Borough, for the report of a reckless driver. It was learned that the reckless driving was occurring between 7 and 7:30 a.m. regarding vehicles not stopping for a school bus.

### **Thursday February 8**

At 7:46 p.m. officers were dispatched to US Highway 6 and State Highway 618, Sadsbury Twp., for the report of a hit and run crash. It was learned that a 32 year old Linesville female was west on US 6 when a truck turned in front of her vehicle causing the crash. The truck continued north on State Hwy 618. Officers later located the vehicle and 17 year old Meadville male operator. Information was obtained and charges filed. There were no reported injuries.

### **Friday February 9**

At 10:46 p.m. officers located a suspicious vehicle at a Conneaut Lake Road business, Sadsbury Twp. All was determined to be okay with the vehicle.

### **Saturday February 10**

At 7:05 p.m. officers were dispatched to State Highway 285 and W. Townline Road, Sadsbury Twp., for the report of a vehicle in the ditch. It was learned that a 53 year old Pittsburgh male was eastbound on the highway and lost control of the vehicle entering the ditch. Upon towing the vehicle back onto the roadway there was no visible damage and the vehicle driven from the scene.

**Miscellaneous.** Officers responded to assist fire, EMS, and citizens on 7 occasions and answered 0 alarm call. Patrol officers conducted 6 traffic stops resulting in 0 traffic citations being issued.
