

## **Conneaut Lake Regional Police**

### **Weekly Police Blotter**

#### **Week of February 11, 2018**

##### **Sunday February 11**

At 7:48 p.m. officers were dispatched to a State Highway 18 residence, Sadsbury Township, for the report of a suspicious person. The caller reported an unknown male walking around an apartment building. Officers were unable to locate any persons.

##### **Monday February 12**

At 2:33 p.m. officers were dispatched to Conneaut Lake Road and State Highway 18, Sadsbury Twp., for the report of roadway debris. While officers were removing nails from the traffic lane with emergency lights activated, they witnessed a minor traffic crash. It was determined that a 21 year old Jamestown PA female was slowing her vehicle for the officers and her vehicle was rear-ended by a vehicle operated by a 22 year old Cochran male. There were no reported injuries.

At 3:40 p.m. officers were dispatched to a Hickory Street residence, Sadsbury Twp., for the report of harassment. It was learned that an 11 year old female was being harassed via social media by known persons. The investigation is continuing.

##### **Tuesday February 13**
