Sunday March 04

At 9:26 a.m. officers were dispatched to a Keene Road residence, Sadsbury Twp., for the report of a burglary. It was learned that unknown person(s) forced entry to a vacant residence however nothing was discovered missing.

At 10:31 a.m. officers were dispatched to the 9800 block of US Highway 6, Sadsbury Twp., for the report of an injured deer in the roadway. Officers were unable to locate any injured animals in the roadway.

Monday March 05

Tuesday March 06

While responding to the scene, officers located the suspect vehicle and obtained operator information for the 36 year old Conneaut Lake male. Multiple charges are pending.

At 9:31 p.m. officers were dispatched to a Conneaut Lake Road motel, Sadsbury Twp., for the report of an overdose. Upon arrival with EMS, a 61 year old Conneaut Lake male was located unconscious from a heroin overdose. EMS personnel revived the male with Narcan and he was transported to the hospital.

Thursday March 08
