Sunday April 01

At 11:17 a.m. officers were dispatched to the railroad tracks intersection with Leach Road, Sadsbury Twp., for the report of a tree down. It was learned that a fallen tree was completely blocking the railway. Norfolk Southern Railroad was notified.

At 7:16 a.m. officers were dispatched to the 12000 block of Conneaut Lake Road, Sadsbury Twp., for the report of a traffic violation. The investigation revealed that a 29 year old Meadville male failed to stop for the flashing red signals of the school bus. A citation was filed.

Wednesday April 04

At 3:25 p.m. officers were dispatched to a State Street business, Conneaut Lake Borough, for the report of theft. It was learned that unknown person(s) forcibly entered a vending machine and removed currency.

At 4:15 p.m. officers were dispatched to a US Highway 6 residence, Sadsbury Twp., for the report of a dead deer. It was learned that the property owner had a deceased deer in his yard after apparently being struck by a vehicle and wanted an officer to remove the deer. The subject was referred to the PA Game Commission.

At 9:26 p.m. officers located a suspicious vehicle at a Conneaut Lake Road business, Sadsbury Twp. After a brief investigation all appeared to be okay with the vehicle.

Thursday April 05

At 10:09 a.m. officers were dispatched to a Konneyaut Trail business, Sadsbury Twp., for the report of bad checks. It was learned that a known male presented 2 separate checks for \$9,000 which were not honored by the bank. The investigation and charges are pending.

Friday April 06

At 11:47 a.m. officers observed a vehicle passing multiple vehicles on Water Street, Conneaut Lake Borough, and attempted to initiate a traffic stop on the vehicle. The violator failed to stop and officers followed the vehicle west on State Highway 285 with emergency lights and siren activated. Officers terminated the emergency operations for safety reasons and went to the residence of the registered owner and located the vehicle. Officers were later able to identify the operator as a 64 year old Espyville male and multiple citations are pending.

Saturday April 07

At 12:32 a.m. officers were dispatched to US Highway 6 and State Highway 618, Sadsbury Twp., for the report of a motor vehicle crash. Upon arrival it was learned that a vehicle traveling south on 618 failed to negotiate a turn onto US Hwy 6 and struck an embankment. Officers located a 48 year old Union City female passenger unconscious and summoned EMS. The operator, a 51 year old Springdale, PA male, was arrested for Driving Under the Influence.

At 8:38 a.m. officers were dispatched to the 7400 block of US Highway 6, Sadsbury Twp., for the report of a motor vehicle crash. It was determined that a 58 year old Conneaut Lake male was traveling west on the highway and due to icy road conditions failed to negotiate a curve and entered the yard of a residence. There were no reported injuries and the vehicle had to be towed from the scene.

At 9:36 a.m. officers were dispatched to the 11000 block of Conneaut Lake Road, Sadsbury Twp., for the report of a loose dog running in traffic on the highway. Officers returned the dog to its owner on High Street in Conneaut Lake Borough.

At 12:47 p.m. officers were dispatched to Conneaut Lake Road and Old State Road, Sadsbury Twp., for the report of a possible intoxicated male. It was reported that a male was continuously staggering and falling down while walking along the roadway. Officers were unable to locate the male.

Miscellaneous. Officers responded to assist fire, EMS, and citizens on 1 occasion and answered 0 alarm calls. Patrol officers conducted 6 traffic stops resulting in 4 traffic citations being issued.
