### **Weekly Police Blotter**

#### **Week of April 15, 2018**

##### **Sunday April 15**

At 8:27 a.m. officers were dispatched to a Campbell Road residence, Sadsbury Twp., for the request of a welfare check. Officers checked the residents and all appeared to be okay.

At 2:27 p.m. officers were dispatched to a State Street residence, Conneaut Lake Borough, for a property dispute. It was learned that a male and female were arguing over personal property rights and were referred to civil action over the property. Prior to the officers' departure, the parties came to agreement and exchanged the property.

##### **Monday April 16**

At 7:18 a.m. officers were dispatched to N. 2<sup>nd</sup> Street and Church Lane, Conneaut Lake Borough, for the report of a motor vehicle crash. A 21 year old Meadville male reported that the night prior he struck a fire hydrant and failed to remain at the scene and report the crash. The investigation is pending.

At 2:10 p.m. officers were dispatched to a Leach Road residence, Sadsbury Twp., for the report of endangering the welfare of a child. The investigation continues.

##### **Tuesday April 17**

At 6:55 a.m. officers were dispatched to an Ellion Road business, Sadsbury Twp., for the report of harassment. A known male was calling on the telephone and threatening business management. Officers located the male by telephone and he was issued a cease and desist order.

At 9:15 a.m. officers were dispatched to a Konneyaut Trail residence, Sadsbury Twp., for the report of endangering the welfare of children. The investigation revealed that the incident occurred in Mercer County and the incident was currently under investigation by Mercer authorities.

At 9:30 a.m. officers were dispatched to an Old State Road apartment building, Sadsbury Twp., for the report of a domestic argument. It was learned that a male and female were involved in a verbal argument that escalated to items being thrown in the residence.

At 4:01 p.m. officers were dispatched to Old State Road, Sadsbury Twp., for the report of a traffic violation. Officers were unable to locate the vehicle.

##### **Wednesday April 18**

#### **Thursday April 19**

A 45 year old Conneaut Lake male was westbound traveling in the inside lane when he thought a vehicle in front of him was stopping to enter a business. There were no reported injuries and both vehicles were driven from the scene.

#### **Friday April 20**

At 1:24 p.m. officers were dispatched to a High Street residence, Conneaut Lake Borough, for the report of a neighbor dispute. It was learned that a 32 year old Meadville female was dropping off her son at his father's residence when a 53 year old intoxicated female neighbor exited her residence and confronted the woman. Harassment charges were filed against the neighbor.

At 2:35 p.m. officers were dispatched to the 11000 block of State Highway 285, Sadsbury Twp., for the report of a traffic complaint. The caller reported that a vehicle towing a trailer full of gravel rounded a curve in the roadway, shifting the load and causing stones to be thrown from the trailer striking the caller's vehicle.

At 4:57 p.m. officers were dispatched to the 12000 block of Conneaut Lake Road, Sadsbury Twp., for the report of a traffic complaint. The caller reported a red Chevrolet pick-up traveling at a high rate of speed. Officers were unable to locate the vehicle.

At 7:29 p.m. officers were dispatched to the intersection of Water Street and 2<sup>nd</sup> Street, Conneaut Lake Borough, for the report of a malfunctioning traffic light. Officers determined the light was functioning properly.

#### **Saturday April 21**
