### **Weekly Police Blotter**

#### **Week of June 17, 2018**

##### **Sunday June 17**

At 3:05 p.m. officers were dispatched to a South 4<sup>th</sup> Street residence, Conneaut Lake Borough, for the request of a welfare check. Officers were unable to locate the subject.

At 9:29 a.m. officers were dispatched to a High Street residence, Conneaut Lake Borough, for the report of a theft. A 61 year old Conneaut Lake female reported that a known subject stole a full fuel can from the property. The incident was captured on a surveillance camera and the investigation is continuing.

At 12:25 p.m. officers were dispatched to Water Street and 4<sup>th</sup> Street, Conneaut Lake Borough, for the report of a motor vehicle crash. It was learned that a log truck operated by a 21 year old Clarks Mills male attempted a right turn from the left lane and impacted a vehicle operated by a 28 year old Linesville female. There were no reported injuries.

At 3:15 p.m. officers were dispatched to a Comstock Street apartment building, Sadsbury Twp., to assist Linesville Police in serving an arrest warrant. The 48 year old Conneaut Lake male was not at the building and was located a short time later in Harmonsburg and arrested by the officers for drug delivery resulting in death.

#### **Thursday June 21**

The 54 year old Conneaut Lake male was located and arrested for outstanding warrants from Allegheny County. Charges are pending against a 61 year old Conneaut Lake male for harboring and hiding the wanted subject.

At 4:55 p.m. officers were dispatched to Woodland Avenue, Sadsbury Twp., for the report of a loose dog in the roadway. Officers were unable to capture the dog.

At 11:31 p.m. officers were dispatched to a High Street residence, Conneaut Lake Borough, for the report of a fight. It was learned that no fight occurred but some males were threatening via social media to come to the residence to fight another male. No one ever appeared at the residence. Officers followed up with the suspects.

#### **Saturday June 23**

At 8:03 p.m. officers assisted with traffic control on South 1<sup>st</sup> Street, Conneaut Lake Borough, for a tree down blocking the roadway until it could be removed by the VFD.
