# Weekly Police Blotter

## Week of June 24, 2018

### Sunday June 24

At 2:05 a.m. officers were dispatched to multiples calls at a Lake Street address, Sadsbury Twp., for a harassment incident between two males. The two males reportedly had a dispute over fireworks in the area. An agreement was met between the two males and officers cleared.
