Weekly Police Blotter

Week of July 15, 2018

Sunday July 15

At 3:15 a.m. officers were dispatched to a Lake Street hotel, Sadsbury Twp., for the report of a hit and run crash. A known vehicle drove through shrubbery and the investigation is continuing.

At 10:22 a.m. officers were dispatched to a State Highway 18 business, Sadsbury Twp., for the report of illegal dumping. Prior to officer arrival, the business owner made contact with a neighbor that illegally dumped garbage on the property and the issue was resolved.

At 10:35 a.m. officers were dispatched to a Cherry Avenue residence, Sadsbury Twp., for the report of a check welfare. Officers made contact with the subject and he was distraught over issues with the person that owned the building. He was referred to a civil attorney.

At 2:21 p.m. officers were dispatched to a North 2nd Street residence, Conneaut Lake Borough, for the report of criminal mischief. A residence window was broken by a rock.

At 4:12 p.m. officers were dispatched to a High Street residence, Conneaut Lake Borough, for the report of a barking dog. Contact was made with the dog owner who was out of town and a person responded to care for the dog.

At 5:11 p.m. officers were dispatched to a Cherry Avenue residence, Sadsbury Twp., for the report of a check welfare. Officers made contact with the subject and removed a bottle of anti-freeze solution after the male kept posting the bottle on social media inferring a behavioral disorder.

At 11:30 p.m. officers located a suspicious male in the area of North 1st Street and Water Street, Conneaut Lake Borough. After contacting the male subject all was determined to be okay.

Monday July 16

At 12:47 a.m. officers were dispatched to a Cherry Avenue residence and business, Sadsbury Twp., for the report of a criminal trespass. It was learned that a 74 year old intoxicated male forced entry into a business attached to his efficiency apartment due to a water leak. The intoxicated male confronted officers and was detained for threatening behavior. Charges were filed for public drunkenness.

At 11:03 a.m. officers were dispatched to a Cherry Avenue residence, Sadsbury Twp., for the report of a behavioral disorder. Officers assisted the ambulance with arrangements for a male to be transported for medical assistance.

At 11:40 a.m. officers were dispatched to water Street, Conneaut Lake Borough, for the report of multiple traffic complaints. Multiple motorists reported traffic congestion due to construction.

At 4:11 p.m. officers were dispatched to Icehouse Park, Sadsbury Twp., for the report of illegal dumping. It was learned that unknown persons are using the park dumpster for household trash.

At 6:21 p.m. officers were dispatched to a High Street residence, Conneaut Lake Borough, for the report of a child custody issue. The caller reported that the male parent was to retrieve the child and was afraid the male would cause issues requesting an officer for a civil stand-by. The male failed to appear to retrieve the child.

A 25 year old Atlantic male reported that upon arriving at the residence he observed a 22 year old Michigan male at the residence who was told not to return to the property when no one was present. Some pushing and shoving occurred prior to police arrival. The Michigan male obtained personal property and left the area.

At 8:03 p.m. officers were dispatched to a High Street residence, Conneaut Lake Borough, for the report of a child custody issue. The caller reported that the male parent was to retrieve the child and was afraid the male would cause issues requesting an officer for a civil stand-by. The male appeared to retrieve the child and the caller yelled at the male for the entire child exchange.

Tuesday July 17

At 12:40 a.m. officers were dispatched to a Lake Street hotel, Sadsbury Twp., for the report of an unauthorized use of motor vehicle. A 24 year old Meadville female reported loaning her car to a fellow employee, a 37 year old Conneaut Lake male and he failed to return the vehicle. The caller eventually located the vehicle later the next day.

At 4:21 p.m. officers were dispatched to the 8500 block of State Highway 285, Sadsbury Twp., for the report of suspicious activity. Caller reported that persons exited a gold in color Pontiac Vibe requesting to search the property for bugs in a field. The subjects were not located in the area by officers.

At 9:35 p.m. officers were dispatched to the area of Conneaut Lake Road and State Highway 18, Sadsbury Twp., for the report of a reckless driver. Officers were unable to locate the vehicle after a search of the area.

At 10:22 p.m. officers were dispatched to an Utley Avenue residence, Sadsbury Twp., for a property dispute. A 25 year old Meadville female reported that she attempted to obtain personal belongings from a 27 year old Conneaut Lake male and was refused entry. Upon officer arrival, the female began yelling at officers and after calming the situation the female did obtain clothing and a TV. After the remote control could not be found the female again became disruptive refusing to leave. Upon being threatened with arrest, the female reluctantly left the area with her belongings.

Wednesday July 18

At 10:59 a.m. officers were dispatched to a High Street residence, Conneaut Lake Borough, for a child custody issue. The caller was referred to a civil attorney as no court ordered custody documents existed.

At 9:01 p.m. officers were dispatched to a Bank Road residence, Sadsbury Twp., for the report of a burning complaint. It was determined the resident was in violation of township burning ordinance with the large trash and household goods fire. After contact could not be made with the resident, the VFD responded and extinguished the fire. Citations were filed against the property owner.

At 11:23 p.m. officers were dispatched to a Mohawk Drive residence, Sadsbury Twp., for the report of a suspicious vehicle. Officers were unable to locate anything upon arrival to the area.

Thursday July 19

At 8:39 a.m. officers were dispatched to a Woodland Avenue residence, Sadsbury Twp., for the report of a hit and run crash. An unknown vehicle struck the caller's vehicle overnight.

It was learned that an acquaintance of the caller was suspected of hacking the caller's social media information and spreading mistruths about the caller. Caller requested documentation of the call only and no investigation.

The business reported a vehicle parked in the parking lot for a week and a male was currently sleeping in the vehicle. Officers identified the homeless male who was awaiting a friend bringing gas for his vehicle. The male was given a time frame to depart the lot and a later check of the property revealed the male had departed.

A male reported that upon return to his residence the property owner had changed the locks and he could not enter. Both the caller and the property owner were referred to civil attorneys, again.
