### **Weekly Police Blotter**

#### **Week of July 22, 2018**

##### **Sunday July 22**

At 8:17 a.m. officers were dispatched to the 11000 block of Iroquois Road, Sadsbury Twp., for the report of a theft. Unknown persons removed green traffic signs purchased personally by the caller requesting drivers reduce speed in the area.
