Week of August 19, 2018

Sunday August 19

At 12:06 a.m. officers were dispatched to a Lakeside Drive residence, Sadsbury Twp., for the report of a behavioral disorder. The juvenile was taken by private vehicle to the hospital for assistance.

At 10:36 a.m. officers were dispatched to Mohawk Drive, Sadsbury Twp., for the report of a burning complaint. Officers were unable to locate any violations.

Monday August 20

At 1:08 a.m. officers located multiple garbage cans in the roadway on Lakeside Drive, Sadsbury Twp. Officers removed the cans from State Highway 18 to Ellion Road.

At 6:49 a.m. officers located a large metal tool box in the roadway at State Highway 618 and Ellis Avenue, Sadsbury Twp. The tool box can be identified and retrieved at the police station.

At 1:56 p.m. officers were dispatched to a Sunset Avenue residence, Sadsbury Twp., for the report of suspicious activity. An unknown female had been seen rummaging through a mailbox and later observed in the caller's garage. When observed exiting the garage with a fuel can the female was confronted and ran to the vehicle fleeing the area.

At 6:41 p.m. officers were dispatched to a Bond Court residence, Sadsbury Twp., for the report of a burglary in progress. Upon arrival it was learned that an ex-tenant had entered a property to retrieve personal belongings. The parties were referred to civil attorneys.

Tuesday August 21

This has been an ongoing issue and charges were filed against the male.

At 8:37 p.m. officers were dispatched to Conneaut Lake Road, Sadsbury Twp., to assist Vernon Twp. Police in locating a shoplifting suspect that fled their area. Officers were unable to locate the vehicle on the roadway.

At 9:49 p.m. officers were dispatched to a Mantor Street residence, Sadsbury Twp., for the report of suspicious activity. A 33 year old Conneaut Lake male reported that an unknown person is cutting wires and damaging plumbing under a mobile home that he was renovating.
