### **Weekly Police Blotter**

#### **Week of September 16, 2018**

##### **Sunday September 16**

At 12:31 a.m. officers located a suspicious vehicle as a State Highway 18 business, Sadsbury Twp. After a brief investigation all was determined to be okay.

At 3:22 a.m. officers were dispatched to the 10000 block of Woodland Avenue, Sadsbury Twp., for the report of a motor vehicle crash. It was determined that a 51 year old Hermitage PA male was operating a motorcycle west on the roadway when he lost control of the motorcycle resulting in a crash. The male was transported to the hospital for injuries. Multiple charges are pending.
