Week of October 21, 2018

Sunday October 21

At 12:50 a.m. officers were dispatched to the Hotel Conneaut, Sadsbury Twp., for the report of a disturbance. Upon arrival it was reported that a male renter was complaining about intoxicated juveniles harassing him. The juveniles were not intoxicated and the complainant left the property prior to officer arrival.

At 9:05 p.m. officers were dispatched to the 11000 block of State Highway 285 near Adsit Cemetery, Sadsbury Twp., for the report of a motor vehicle crash. It was determined that Amanda Cook, age 25 of Conneaut Lake was westbound on the highway when she failed to negotiate a curve and entered the eastbound lane striking a vehicle operated by 20 year old Kaycee Keas of Conneaut Lake. Cook was ejected from the vehicle upon impact. Cook was flown to Erie for medical care and Keas was transported to Meadville. The investigation is continuing.

Monday October 22

At 7:55 p.m. officers located a vehicle along US Highway 6 near School Road, Sadsbury Twp., with the emergency flashers on. It was learned that Charlene Shaffer, age 48 of Linesville was traveling on the highway and struck a deer. There were no reported injuries.

Tuesday October 23

Friday October 26
