##### **Monday November 19**

At 3:23 p.m. officers were dispatched to a residence in the 12000 block of State Highway 618, Sadsbury Twp., for the report of theft. A 26 year old female accused her 27 year old boyfriend of stealing her keys. The complainant was referred to a civil attorney.
