Sunday December 09

At 1:13 a.m. officers on patrol discovered a verbal domestic argument at the Hotel Conneaut, Sadsbury Twp. Officers learned that a 38 year old Sanford Fl. Female was upset with a 43 year old Centerville PA male for talking with women inside the bar.

At 1:52 p.m. officers were dispatched to the 600 block of High Street, Conneaut Lake Borough, for the report of a dog complaint. It was learned that a male was walking his dog on Strawberry Alley when they were attacked by two loose pit bull type dogs. It was determined by officers that the dogs belonged to 580 High Street, and charges are pending against the dog owner.

At 2:39 p.m. officers were dispatched to a residence in the 11000 block of Woodman Street, Sadsbury Twp., for a request to check the welfare. A Meadville female requested officers check the welfare of a male resident. Officers were unable to locate the male.

Monday December 10

At 6:05 p.m. officers were dispatched to an apartment building in the 10000 block of West Vernon Rd, Sadsbury Twp., to assist Pa Constables in executing arrest warrants. A 36 year old Conneaut Lake male was taken into custody.

At 11:57 a.m. officers were dispatched to the Just Sleep Motel Conneaut Lake Road, Sadsbury Twp., for a check the welfare request. Officers discovered a deceased 70 year old Mars, PA female in an apartment from natural causes. Officers assisted the county coroner at the scene.

At 4:37 p.m. officers were dispatched to the Dollar General US Highway 6, Pine Twp., to assist Linesville Police and Pa State Troopers with a domestic argument.

At 4:57 p.m. officers were dispatched to a residence in the 12000 block of State Highway 618, Sadsbury Twp., for the report of a domestic argument. It was determined that a 26 year old Conneaut Lake female locked her 27 year old boyfriend out of the house. The boyfriend was returned to the residence by officers and the two were referred to civil attorneys.

At 6:02 p.m. officers were again dispatched a residence in the 12000 block of State Highway 618, Sadsbury Twp., for a verbal domestic argument. Officers separated the parties and the female called her other boyfriend and departed the residence.

Thursday December 13

At 6:00 a.m. officers were dispatched to the 12000 block of Conneaut Lake Road, Sadsbury Twp., for the report of a motor vehicle crash. It was learned that David Harding, 27, Conneaut Lake was eastbound when his vehicle struck a deer. There were no reported injuries and the vehicle required towing.

At 5:32 p.m. officers were dispatched to the 10000 block of Utley Avenue, Sadsbury Twp., for a child custody issue. Officers referred the male caller to civil authorities.

Friday December 14

At 12:30 a.m. officers were dispatched to a residence in the 10000 block of State highway 18, Sadsbury Twp., for the report of a physical domestic argument. It was learned that the female spouse assaulted and damaged the residence. The female departed the residence prior to police arrival and charges are pending.

At 8:09 p.m. officers were dispatched to the area of Conneaut Lake Road and Ellion Road, Sadsbury Twp., for the report of a reckless driver. Officers were unable to locate the vehicle.

At 11:08 p.m. officers were dispatched to a residence in the 700 block of Water Street, Conneaut Lake Borough, for the report of a physical domestic argument. It was learned that a female from California reported the domestic. A 26 year old Conneaut Lake male departed the residence prior to police arrival after assaulting his 31 year old female spouse and a 28 year old Conneaut Lake male also in the residence. Charges are pending.

Saturday December 15

At 12:12 a.m. officers located a female running on North 4th Street near Water Street, Conneaut Lake Borough. Upon contact it was learned that the female was in the laundromat when her dog got loose and she was chasing it in the street. Officers assisted with retrieving the dog.

At 6:30 p.m. officers were dispatched to Aldina Drive and Sargent Street, Sadsbury Twp., for the report of a disabled motorist. Upon arrival it was determined that Linda Stewart, 56, Greenville, attempted to turn onto the street and entered a roadside ditch. The vehicle was pulled from the ditch by neighbors and the property owner.

At 8:59 p.m. officers were dispatched to an apartment building in the 12000 block of Lakeside Drive, Sadsbury Twp., for a request for officer. Upon arrival the female caller reported that after a child custody exchange she felt a male placed narcotics in her vehicle to get her in trouble. Officers searched her vehicle and no narcotics were located.

Miscellaneous. Officers responded to assist fire, EMS, and citizens on 8 occasions and answered 3 alarm calls. Patrol officers conducted 7 traffic stops resulting in 5 traffic citations being issued.
