Sunday January 06

At 12:15 a.m. officers located a suspicious vehicle at the Manning Boat Launch, N. Shenango Twp. Officers identified the 21 year old Cochran female and 35 year old McKean male occupants and determined all to be okay.

Monday January 07

At 5:50 a.m. officers were dispatched to State Highway 18 and Shady Avenue, Sadsbury Twp., for the report of a motor vehicle crash. It was learned that Adam Dunn, 37, Meadville was traveling on the highway when a deer ran into the side of his vehicle. There were no reported injuries.

At 9:14 a.m. officers were dispatched to the 11000 block of State Highway 285, Sadsbury Twp., for the report of a motor vehicle crash. It was learned that Nathan Colosimo, 20, Boyers, was traveling on the ice covered roadway and lost control of the vehicle while negotiating a curve and entered a roadside ditch. There were no reported injuries but the vehicle had to be towed due to damage.

Tuesday January 08

At 10:00 a.m. officers were dispatched to the Just Sleep Motel Conneaut Lake Road, Sadsbury Twp., for the report of a wanted person. The investigation revealed that in fact the person identified was not wanted from the State of California.

At 11:08 a.m. officers were advised of a possible sexual assault that occurred somewhere in the Conneaut Lake area in the 1970's. The male complainant advised the Catholic Diocese that he was assaulted by a now deceased priest and the Diocese contacted Child Line as required by Child Protective Services Law.

Wednesday January 09

At 10:48 p.m. officers were dispatched to a residence in the 2000 block of Quincy Lane, N. Shenango Twp., for the report of a domestic argument resulting in a possible overdose. Upon arrival of officers an involved 50 year old male was observed fleeing the residence in a vehicle. Upon stopping the vehicle on Pilgrim Lane it was determined that in fact the male had not attempted to overdose but was driving under suspension and a citation was filed for that offense.

At 12:07 p.m. officers were dispatched to State Highway 18 and Lakeside Drive, Sadsbury Twp., for the report of a disabled motorist. Officers assisted a semi-tractor trailer driver turn around on the highway after he became lost and entered a housing development.

At 7:07 p.m. officers were dispatched to State Highway 285 and Linesville-Hartstown Road, N. Shenango Twp., for the report of a motor vehicle crash. It was learned that Arthur Dowling, 28, Rome OH, stopped at a stop sign and entered the intersection believing it was a 4-way stop, at which time he struck a vehicle operated by Sara Jacklett, 36, Linesville. There were no reported injuries to any occupants but

the Dowling vehicle was towed from the scene due to damage and a citation was issued to Dowling for the violation.

At 6:10 p.m. officers were dispatched to the Just Sleep Motel Conneaut Lake Road, Sadsbury Twp., for the report of a behavioral disorder. The 40 year old male was transported for medical care by ambulance. While at the scene it was learned that a 37 year old Union City female was wanted by the Erie County Sheriff's Office. She was arrested and placed in the county jail.
