Sunday January 13

At 1:57 a.m. officers located a female walking in the middle of State Highway 618 near Maple Avenue, Sadsbury Twp., and upon contact were notified of a suicidal male walking further up the roadway. Officers located and identified the 36 year old Cambridge Springs male. During questioning some controlled substances were located on the male. The investigation is continuing.

At 12:06 p.m. officers were dispatched to a residence in the 100 block of North 2nd Street, Conneaut Lake Borough, to assist Meadville City Police in locating a wanted female. Officers were unable to locate the female.
