Week of March 17, 2019

Sunday March 17

At 1:39 a.m. officers were dispatched to the Hotel Conneaut, Lake Street, Sadsbury Twp., for the report of an intoxicated male causing a disturbance. The male left the property prior to officer arrival and officers were unable to locate the male in the area.

At 1:47 a.m. while officers were searching for a male near the Hotel Conneaut, Lake Street, Sadsbury Twp., officers located a 43 year old Conneaut Lake male passed out in a vehicle in the rear parking lot. Upon contact the male was intoxicated and an odor of marijuana emitted from the vehicle. No illegal drugs were located but the male was taken into custody for Public Drunkenness.

At 3:05 a.m. officers were dispatched to the Hotel Conneaut, Lake Street, Sadsbury Twp., for the report of an intoxicated male causing a disturbance. The male left the property prior to officer arrival and officers were unable to locate the male in the area.

At 6:34 a.m. officers were dispatched to a Water Street business, Conneaut Lake Borough, for the report of a 911 call check. All was determined to be okay.

Tuesday March 19

Wednesday March 20

At 2:28 a.m. officers were dispatched to Conneaut Lake Road near Ellion Road, Sadsbury Twp., for the report of two females running into the roadway. Officers checked the area and were unable to locate anyone.

At 8:07 a.m. officers were dispatched to a residence in the 7700 block of State Highway 285, Sadsbury Twp., for the report of suspicious activity. It was reported that someone may be knocking at the residence door but officers were unable to locate anyone in the area.

Thursday March 21

At 7:20 a.m. officers were dispatched to a Water Street business, Conneaut Lake Borough, for possible firearms act violations. Upon researching and contacting the two parties involved it was learned that the firearms applications were simply incorrectly completed by the applicants and no violations occurred.

Friday March 22

At 12:45 a.m. officers were stopped by a pedestrian at 3rd Street and Water Street, Conneaut Lake Borough, by a Maryland resident requesting assistance in locating a family member's residence. Officers assisted and provided directions to Jamestown, PA.

At 2:34 a.m. officers located a suspicious male at State Highway 285 and N. Martin Drive, N. Shenango Twp. It was learned that the 26 year old Espyville male was playing Pokemon Go.

At 10:08 a.m. officers were dispatched to a residence in the 9600 block of US Highway 6, Sadsbury Twp., for the report of a loose dog. It was reported that a large tan dog with an orange collar was in the complainant's yard. Officers searched the area and were unable to locate the dog.

At 11:30 a.m. a 66 year old Conneaut Lake male walked into the police station and requested officers check his blood alcohol content. The male tested positive for alcohol and officers learned that in fact he drove to the station. The male was provided a courtesy ride home as no officers observed him actually driving.

At 2:22 p.m. officers were dispatched to the area of State Highway 285 and Leach Road, Sadsbury Twp., for the report of two suspicious males. Officers located the males and learned they were soliciting for gas and electric companies. The males were told to cease their activities until a proper permit could be obtained.

At 8:46 p.m. officers were dispatched to Conneaut Area Middle School, Sadsbury Twp., for the report of threats. It was learned that a student received a social media message advising of another student's house possibly going to be damaged. The incident was referred to the district's SRO for follow up.

Saturday March 23

At 4:19 p.m. officers were dispatched to Shumaker Street and McClure Street, Sadsbury Twp., for the report of a motor vehicle crash. It was learned that Molly Fenton, 34, Meadville and a male passenger were seated in a parked car when an All-Terrain Vehicle was driving on the roadway and struck some mailboxes and then her vehicle. The male operator provided a driver license and then left the scene. Multiple charges are pending.

At 5:20 p.m. officers located a male involved in an earlier crash near Shumaker and McClure at the Hotel Conneaut, Sadsbury Twp. Officers identified Joshua Craig, 32, Conneaut Lake, as the operator and took him into custody for an outstanding bench warrant.

At 8:10 p.m. officers were dispatched to the Hotel Conneaut, Lake Street, Sadsbury Twp., for the report of an out of control male damaging hotel property. Officers made contact with the 18 year old Meadville male who appeared to be affected by an unknown hallucinogen. The male was taken into custody and transported to the hospital for evaluation. Charges are pending.

Miscellaneous. Officers responded to assist fire, EMS, and citizens on 13 occasions and answered 5 alarm calls. Patrol officers conducted 15 traffic stops resulting in 14 traffic citations being issued.
