### **Weekly Police Blotter**

#### **Week of April 07, 2019**

##### **Sunday April 07**

At 2:55 p.m. officers were dispatched to Lakeside Drive and Oak Street, Sadsbury Twp., for the report of juveniles riding off road motorcycles on the roadway. Officers located two male juveniles in the rear yard of a residence and they were issued a verbal warning for operating on the roadway.

### **Friday April 12**

At 3:47 a.m. officers attempted to conduct a traffic stop on an older blue Chevrolet truck bearing Ohio registration in the 100 block of Water Street, Conneaut Lake Borough, for a traffic violation. The male operator and female passenger failed to stop and fled the area west on Water Street at a high rate of speed. Officers terminated the incident after the vehicle turned north on Campbell Road. The investigation is continuing.
