Week of April 14, 2019

Sunday April 14

At 7:28 a.m. officers were dispatched to N. Shenango Twp., for the report of a possible vehicle crash involving entrapment. It was learned that the Ashtabula County OH 911 Center received a call from a male advising that he was in a red truck that rolled over in a field and he was entrapped. The call was dropped by the cellular company and pinged off a cellular tower in Andover. Officers checked the entire area and were unable to locate anything.

At 10:45 a.m. officers were met at the station by a Harmonsburg male that reported a fraud at the Dry Dock Bar, State Highway 618, Sadsbury Twp. The male reported winning a game and not being paid the full amount. The bar was contacted and issues were being worked out.

At 5:43 p.m. officers were dispatched to the 11000 block of State Highway 285, Sadsbury Twp., for the report of a motor vehicle crash. It was learned that Samuel Orr, 20, Conneaut Lake, was travelling on the roadway when his vehicle sustained a malfunction which caused him to leave the roadway and strike a utility pole. There were no reported injuries.

At 6:41 p.m. officers were dispatched to South Lake Road and Oak Lane, N. Shenango Twp., for the report of a motor vehicle crash. It was learned that John Goughenour Sr., 85, Espyville was searching for a tornado shelter after tornado warnings were issued. While travelling on S. Lake Rd. he did not observe a large tree across the roadway due to heavy winds and rain and struck the tree. He was transported for medical care and the vehicle was towed from the scene.

Monday April 15

At 1:23 p.m. officers were dispatched to US Highway 6 and Greiser Road, Sadsbury Twp., to assist PA State Police with arresting a male with a warrant while on a traffic stop.

Tuesday April 16

At 10:40 a.m. officers were dispatched to a residence in the 3100 block of State Highway 285, N. Shenango Twp., for the report of a suspicious vehicle. The male caller reported a vehicle driving slowly past his residence.

At 3:30 p.m. officers were dispatched to the 12000 block of Comstock Street, Sadsbury Twp., for a lost dog. Caller reported her dog missing in the area.

At 5:29 p.m. officers were dispatched to the Sheetz, Water Street, Conneaut Lake Borough, for the report of a possibly intoxicated male. Upon arrival, PA State Police had already contacted the male and were handling the incident.

At 7:10 p.m. officers were dispatched to a residence in the 600 block of High Street, Conneaut Lake Borough, for a check the welfare. The caller requested officers make contact with a male whose family member was ill. Officers were unable to locate anyone at the residence.

At 7:32 p.m. officers were dispatched to a residence in the 8900 block of South Lake Road, N. Shenango Twp., for the report of a missing person. Prior to arrival, officers were canceled as the person returned home after walking the dog.

Thursday April 18

At 12:08 p.m. officers were dispatched to a residence on Blair Street, Sadsbury Twp., for the report of a possible burglary. Known persons apparently removed items from a locked storage shed. The investigation is continuing.

At 12:23 p.m. officers were dispatched to Conneaut Lake Road, Vernon Twp., to assist Vernon Police with traffic control for an oversized load stuck on Gable Hill.

At 7:15 p.m. officers were dispatched to a residence in the 8800 block of Delaware Lane, N. Shenango Twp., for the report of criminal mischief. Unknown persons smashed several windows of the complainant's residence.

Friday April 19

At 12:17 a.m. officers were dispatched to State Highway 285 and Church Road, N. Shenango Twp., for a traffic violation. A red Camaro was reported to be speeding in the area and officers were unable to locate the vehicle.

Saturday April 20

At 12:55 a.m. officers were dispatched to the 1800 block of Crom Road, N. Shenango Twp, for the report of a noise complaint. It was reported that a truck with a loud muffler was repeatedly running up and down a field near residences. Officers located the vehicle and owner and they were given a verbal warning to cease and desist for the remainder of the night.

At 3:30 p.m. officers were dispatched to the 1700 block of Pine Street, N. Shenango Twp., for the report of ATV's on the roadway. Officers located the ATV's and verbal warnings were issued for illegal operation on the roadways.

At 3:40 p.m. officers were dispatched to a residence in the 10000 block of Free Road, Sadsbury Twp., for the report of a fraud. The caller reported receiving a check in the mail for a wedding dress transaction that did not occur. The check sender requested the caller to deposit the check and send funds to cover shipping charges. The caller was advised that it was a fraud and not to send the monies or borrow monies on the counterfeit deposited check.

At 23:20 p.m. officers were dispatched to a business on State Highway 18, Sadsbury Twp., after a witness observed a truck pulling a trailered boat from the property. Officers conducted a traffic stop on the vehicle and learned that the driver was the boat owner and cleared removing the boat from the business owners. Officers contacted the business owner by phone and confirmed the information.

Miscellaneous. Officers responded to assist fire, EMS, and citizens on 11 occasions and answered 2 alarm calls. Patrol officers conducted 8 traffic stops resulting in 7 traffic citations being issued.
