### **Weekly Police Blotter**

#### **Week of May 5, 2019**

##### **Sunday May 5**

At 1:24 a.m. officers observed a suspicious vehicle at the Shell gas station, State Highway 18, Sadsbury Twp., with a male passed out in the vehicle. Officers took the 19 year old Atlantic, PA male into custody and he was charged with disorderly conduct.
