Week of May 12, 2019

Sunday May 12

At 12:30 a.m. officers observed an ATV traveling on Us Highway 6 near South Canal Road, Sadsbury Twp. As the ATV turned onto Canal in front of the officer, the officer initiated his emergency lights and siren and the operator attempted to flee accelerating his rate of speed. The 22 year old Jamestown, PA male then attempted to turn onto a dirt access road causing the ATV to roll over ejecting the operator. The male was taken into custody for DUI and other traffic offenses and refused medical treatment.

At 12:59 p.m. officers observed a male possibly violating fishing laws at Blair Bridge on State Highway 285, Sadsbury Twp., after being asked by Pa FBC to keep a watch in the area. It was determined that all was okay and Pa FBC was notified of the officer contact.

At 3:59 p.m. officers were dispatched to the 1300 block of Cayuga Drive, N. Shenango Twp., for a suspicious vehicle. It was learned that surveillance cameras observed a suspicious older model truck on the roadway the night prior shutting off the exterior lights and driving on the roadway. A father reported that he was unable to contact his 27 year old son and was in fear for his well-being as he learned the son withdrew a large amount of money from his bank account and was not answering multiple attempts to locate him. The son was contacted while officers were taking the report and it was learned the son was contacted by phone and a male advised he was from the IRS and was sending a Marshal to arrest him if he didn't obtain Walmart and GameStop gift cards and provide the numbers for back taxes. A fraud annotation was added to the report.

At 2:48 p.m. officers were dispatched to a residence in the 100 block of North 5th Street, Conneaut Lake Borough, for the report of found drug paraphernalia. Officers seized the paraphernalia.

At 4:52 p.m. officers were dispatched to Leach Road and South Lake Road, N. Shenango Twp., for the report of criminal mischief. Unknown person(s) have been damaging street signs along Leach Road and extra patrols were issued for the area.
