Sunday June 23

At 2:08 p.m. officers were dispatched to the Rite Aid, South 3rd Street, Conneaut Lake Borough, for the report of fraud. It was learned that 2 persons purchased money orders for \$519.00 and the debit card presented was later declined. After officers contacted the subjects, reimbursement was made a couple days later.
