### **Weekly Police Blotter**

#### **Week of July 7, 2019**

##### **Sunday July 7**

At 1:34 p.m. officers were dispatched to the 5<sup>th</sup> Street Presbyterian Church, Conneaut Lake Borough, for the report of a theft. It was reported that currency was removed from the building. The investigation is continuing.

##### **Monday July 8**
