## **Weekly Police Blotter**

### Week of July 28, 2019

### **Sunday July 28**

At 5:21 a.m. officers were dispatched to the Hotel Conneaut, Lake Street, Sadsbury Twp., for the report of an unwanted subject. It was learned that hotel personnel attempted to remove Daniel Meehan, 58, Meadville from the property on several occasions as he had not rented a room. It was then reported that Meehan knocked on a room door disturbing the patrons by showing them pornography he had displayed on a lap top computer. The male was arrested and incarcerated at the county jail.
