

## **Conneaut Lake Regional Police**

### **Weekly Police Blotter**

#### **Week of August 4, 2019**

##### **Sunday August 4**

At 1:49 p.m. officers were dispatched to Conneaut Lake Road and Ellion Road, Sadsbury Twp., for the report of a motor vehicle crash. It was learned that Andrew Johns, 75, Rural Valley PA stopped at the stop sign on Ellion Road and attempted to enter the highway when he failed to yield to a vehicle operated by Ryan Smith, 20, Linesville. Multiple persons were transported for medical treatment.

At 4:46 p.m. officers were dispatched to the Sheetz, Water Street, Conneaut Lake Brough, for the report of an intoxicated driver. Officers located the male in the parking lot and it was learned that he operated a motorcycle to arrive at the store. The 56 year old Tarentum PA male obtained an Uber ride home.

At 5:14 p.m. officers were dispatched to Nobles Lane and S. Lake Road, N. Shenango Twp., for the report of vehicles drag racing. Officers were unable to locate the vehicles and an extra check was posted for the area.

At 8:13 p.m. officers were dispatched to a residence in the 11000 block of Center Street, Sadsbury Twp., for the report of a possible prowler. It was reported that a male was checking doors and windows to a residence in an attempt to gain entry. Officers located the male and learned the male was at the residence of his employer and was awaiting his arrival and tried to enter the residence. Officers contacted the employer by telephone and confirmed the information.

##### **Monday August 5**

At 7:56 a.m. officers were dispatched to Hartstown Road near Church Road, N. Shenango Twp., for the report of a motor vehicle crash. It was learned that a 17 year old Hartstown male was traveling on Hartstown Road when for an unknown reason the vehicle drifted off the roadway and entered a roadside ditch. At 1:02 p.m. officers were dispatched to Conneaut Lake Road near the Vernon line, Sadsbury Twp., for the report of a motor vehicle crash. Albert Kissling, 41, Pittsburgh was eastbound on the highway and struck a deer. There were no reported injuries.

At 9:17 p.m. officers were dispatched to a residence in the 10000 block of State Highway 18, Sadsbury Twp., for a husband reporting his wife passed out and intoxicated in a vehicle at the end of the driveway. Upon contact with the male caller he was extremely intoxicated and officers were unable to locate the female. Officers located the female a short time later in Conneaut Lake Borough and she was completely sober.

At 9:46 p.m. officers were dispatched to South 3<sup>rd</sup> Street, Conneaut Lake Borough, for the report of ATV's on the street. Officers were unable to locate the ATV's.

## **Tuesday August 6**

At 6:00 a.m. officers were dispatched to US Highway 6 and Gehrton Road, Summit Twp., to assist PA State Police by removing a dead deer from the roadway.

A parent reported that their son lost an I-Phone and he attempted to enter the Google search engine to utilize a computer application to find the phone. Upon clicking the first entry on the search engine he was requested to obtain \$800 in gift cards, which he did, as payment to locate the phone. The father was then requested to provide his Wi-Fi PIN and password, which he did. The caller then realized that he was more than likely defrauded.

## **Wednesday August 7**

At 11:57 a.m. officers were dispatched to State Highway 285 and Wilson Road, N. Shenango Twp., for the report of a dog running loose in the game lands. Officers observed the dog but could not get near it and it ran into corn fields.

At 7:42 p.m. officers responded to a traffic complaint that was dispatched at the time of the prior burning complaint at Iroquois Road and Konneyaut Trail, Sadsbury Twp. It was reported that a white pickup truck was driving recklessly and officers were unable to locate the vehicle due to the delayed response. Extra checks of the area were posted.

At 11:33 p.m. officers were dispatched to a residence in the 300 block of High Street, Conneaut Lake Borough, for the report of an ongoing domestic dispute. Both parties claimed physical contact by the other during multiple arguments over a couple days. The investigation is continuing.

**Miscellaneous.** Officers responded to assist fire, EMS, and citizens on 6 occasions and answered 2 alarm calls. Patrol officers conducted 6 traffic stops resulting in 3 traffic citations being issued.
