### **Weekly Police Blotter**

#### **Week of August 11, 2019**

##### **Sunday August 11**

At 10:05 a.m. officers were dispatched to Dry Dock Bar and Grill, State Highway 618, Sadsbury Twp., for the report of a burglary. It was learned that unknown persons forced entry through a window and removed an undetermined amount of cash.

At 10:29 a.m. officers were dispatched to a residence in the 12000 block of Rogers Road, N. Shenango Twp., for the report of a deceased male. The investigation is continuing however initially it appears to be the result of natural causes.

At 6:13 p.m. officers were dispatched to a residence in the 300 block of High Street, Conneaut lake Borough, for the report of a verbal domestic argument.

##### **Monday August 12**

At 1:00 p.m. officers were dispatched to a residence in the 3500 block of Bentley Road, N. Shenango Twp., for the report of theft. It was learned that unknown persons removed 2 bicycles, 2 aluminum ramps, 2 Poulan leaf blowers and a Chicago Electric Welder from an open garage.

The caller reported that the neighbor dogs bark all the time and they overheard the dog owner yelling at the dogs and now they aren't barking anymore and feared they were injured or dead. Officers checked and all dogs were fine.

##### **Tuesday August 13**

At 9:15 a.m. officers were dispatched to Conneaut Lake Road and State Highway 18, Sadsbury Twp., for the report of a motor vehicle crash. It was learned that vehicles operated by Michael Anthony, 25, Meadville and Nicholas Hoffman, 36, Conneaut Lake were westbound on the roadway when Anthony attempted to change lanes striking the other vehicle. One vehicle was towed and there were no reported injuries.

Unknown persons, believed to be boat dock renters, spray painted stenciled notices on docks and parking blocks identifying use by dock renters only. The spray painted property is owned by Conneaut Lake Borough.

At 4:41 p.m. officers were dispatched to a business in the 11000 block of State Highway 18, Sadsbury Twp., for the report of fraud. It was learned the business owner was reporting an unauthorized on line debit to the business account.

A 57 year old female reported that her 33 year old daughter refused to move out of her residence. The caller was referred to legal counsel for an ejectment order.

At 7:43 p.m. officers were dispatched to a residence in the 3800 block of Mohawk Trail, N. Shenango Twp., for the report of trespass. Upon arriving and not being able to locate anyone on the property, officers contacted the caller and learned the caller was 10 miles away and a person they permitted to use the property was refusing to leave.

### **Thursday August 15**

At 6:33 a.m. officers located and removed a dead deer from the roadway at State Highway 285 and School Road, Sadsbury Twp.

At 1:51 p.m. officers were dispatched to Just Sleep Motel, Conneaut Lake Road, Sadsbury Twp., for the report of an unauthorized use of a motor vehicle. The female reported that her husband was not authorized to operate a vehicle loaned to them by his parents and when she awoke she discovered the vehicle missing. The vehicle and husband returned prior to officer arrival.

At 7:02 p.m. officers were dispatched to a residence in the 9600 block of Stillwater Trail, N. Shenango Twp., to assist Allegheny County CYF with a child welfare check. Officers spoke with the children and the grandparents and all appeared to be okay.

At 7:17 p.m. officers were dispatched to the Sunset View Motel, State Highway 618, Sadsbury Twp., for the report of suspicious persons. The caller observed two persons seated near the swimming pool of the abandoned motel. Officers were unable to locate anyone in the area.

### **Friday August 16**

Officers located a 34 year old Darlington, Pa female and a 41 year old New Galilee, Pa male seated on a bench in the rear parking lot. Both advised that they had been drinking all day and became involved in a heated verbal argument. They agreed to separate for some time to sober up.

At 8:17 p.m. officers were dispatched to the Hotel Conneaut, Sadsbury Twp., for the report of a domestic argument. Officers located a 34 year old Darlington, Pa female and a 41 year old New Galilee, Pa male in their hotel room loudly arguing. Both were evicted from the room by ownership.

At 11:08 p.m. officers were dispatched to an apartment building in the 12000 block of W. Vernon Road, Sadsbury Twp., for a landlord/tenant dispute. The landlord requested officers stand by while tenants were removing some personal items from an apartment after the tenants were harassing the landlord.

### **Saturday August 17**

At 4:51 a.m. officers were dispatched to Atlantic Lake Road and Atlantic Road, E. Fallowfield Twp., at the request of Pa State Police for the report of a motor vehicle crash. It was learned that Atlee Detweiler, 24, Greenville, PA was traveling at a high rate of speed and failed to stop at a posted stop sign striking a vehicle operated by Joyce Moore, 68, Adamsville. Moore was flown to St. Elizabeth's Hospital for extensive injuries sustained in the crash. The investigation is continuing and charges are pending.

At 3:51 p.m. a male stopped at the police station and turned over a PA registration plate he observed fall from a vehicle on I-79. Officers determined the registered owner and with assistance from Grove City Police were able to contact the registered owner for retrieval.

At 7:32 p.m. officers were dispatched to a residence in the 10000 block of Horseshoe Drive, N. Shenango Twp., for a missing person report. It was learned that two persons had been missing from the residence for a period of time. Upon officer arrival it was learned that the two persons returned to the residence after searching for crayfish in a nearby stream while family members were out looking for them.

At 7:38 p.m. officers were dispatched to a residence in the 1400 block of Shaker Road, N. Shenango Twp., for the report of an unresponsive overdose subject in a vehicle. NSVFD personnel administered two doses of Narcan and the 55 year old female became responsive. She refused medical transport for medical treatment.

**Miscellaneous.** Officers responded to assist fire, EMS, and citizens on 18 occasions and answered 4 alarm calls. Patrol officers conducted 4 traffic stops resulting in 1 traffic citation being issued.
