# **Weekly Police Blotter**

# Week of September 29, 2019

### **Sunday September 29**

At 12:48 a.m. officers were dispatched to a State Highway 18 business, Sadsbury twp., for a male walking near a closed business. Officers located the male and learned his identity. Officers had the male continue on his way.

At 1:22 a.m. officers were dispatched to Hotel Conneaut, Sadsbury Twp., for the report of an unwanted person. Officers arrived to learn the unwanted person had already left and was no further action needed by officers.

At 2:20 a.m. officers were dispatched to a US Highway 6 residence, Conneaut Twp., to assist the Pennsylvania State Police with a disturbance. Officers arrived first on scene and located an intoxicated male who began to have disregard to officer's commands. Additional officers were requested to the scene and was later taken into custody by Pennsylvania State Police.

At 6:28 p.m. officers were dispatched to a Seneca Trail residence, North Shenango Twp., for the report of a stolen side-by-side. Officers learned of a UTV removed from the property. Note: The side by side was recovered on a later date by the owner in a wooded area disabled.

Officers arrived and learned a 24 year old female had struck a deer causing damage to the vehicle. No injuries occurred as a result of the accident.

### **Tuesday October 01**

At 10:01 a.m. officers were dispatched to a High Street residence, Conneaut Lake Borough, for the report of harassment. Caller related the neighbor was harassing about a tree near the property line causing issues.

At 12:40 p.m. officers were dispatched to the intersection of Conneaut lake Road and state Highway 18, Sadsbury Twp., for a motor vehicle accident. Officers arrived to learn an 80 year old male had failed to yield to oncoming traffic during a left hand turn on a green signal. Male turned in front of a 28 year old female causing the vehicles to collide.

At 1:45 p.m. officers were dispatched to the intersection of South First Street and High Street, Conneaut Lake Borough, for the report of a parking complaint. Caller related the vehicle was parked too close to a fire hydrant. Officers arrived to find the vehicle was not in violation as it was parked a distance to the rear of the hydrant on private property causing no interference to the hydrant if in fact needed for an emergency.

At 11:41 p.m. officers were dispatched to a West Townline address, Sadsbury Twp., for the report of suspicions activity. Officers arrived to find two males in a small creek catching minnows.

### Wednesday October 02

At 10:45 a.m. officers were dispatched to the 7000 block of US Highway 6, Sadsbury Twp., for the report of harassment. Officers learned the caller was believed to have been the victim of an unknwon fraud or scam and was receiving multiple emails.

Officers learned both vehicles were entering the parking area of the business off the roadway when a 70 year male had struck the rear end of the vehicle in front of him operated by a 75 year old male.

### **Thursday October 03**

At 6:06 a.m. officers were dispatched to a State Highway 285 residence, Sadsbury Twp., for the report of a deceased person. Officers arrived to find the deceased and awaited for the coroner to arrive.

At 1:11 p.m. officers were dispatched to a Church Lane apartment building, Conneaut Lake Borough, for the report of harassment. Officers learned a male was contacting an ex-girlfriend via phone and in person continuously and the female wished for the communication to stop. Charge(s) are pending.

At 3:15 p.m. officers were dispatched to a Water Street business, Conneaut Lake Borough, for the report of a pedestrian struck. Officers arrived to find a 72 old female had been struck by the rear end of a vehicle operated by a 41 year old female. The victim was transported by EMS to a medical helicopter to be transported to a trauma center. Incident is under investigation by officers.

#### Friday October 04

At 9:15 a.m. officers were dispatched to a State Highway 285 residence, Sadsbury Twp., for the report of a theft. Officers learned a construction company had received payment to complete a job at the residence in March of this year and to date had not started or completed the job. Investigation is continuing by officers.

At 10:52 a.m. officers were dispatched to the area of Conneaut Lake Road and Ellion Road, Sadsbury Twp., for the report of a motor vehicle accident. Officers arrived to find a 59 year old female had

entered the west bound lane of Conneaut Lake Road from Ellion Road coming into the path of a 20 year female traveling west on Conneaut Lake Road. No injuries occurred as a result of the accident.

At 5:02 p.m. officers were dispatched to the 11000 block of Choctaw Trail, Sadsbury Twp., for the report of fraud. Officers learned the caller had been a victim of a fraudulent scam costing the victim tens of thousands of dollars as money was sent to address out of state that was a fraudulent address.

At 6:28 p.m. officers were dispatched to a Dogwood Lane address, Sadsbury Twp., for suspicious activity. Officered arrived a located an open door to the garage area. Officers checked and secured the building.

## Saturday October 05
