Sunday October 06

At 10:55 a.m. officers were dispatched to a North Martin Drive address, North Shenango twp., for a found child walking on the roadway. Officers arrived and were able to get the child back home to his parents.

The female for unknown reasons traveled to the right hand west bound lane of Conneaut Lake Road in the path of a 44 year old male causing the male to strike head on with her vehicle. The female driver was transported to a local hospital.
