##### **Sunday October 13**

##### **Monday October 14**

At 5:15 p.m. officers were dispatched to an Old State Road residence, Sadsbury Twp., for the report of a noise complaint. Officers arrived and made contact with the actor(s) who received a verbal warning for the noise level coming from within the apartment.

##### **Tuesday October 15**

At 12:33 p.m. officers were dispatched to an Old State Road address, Sadsbury Twp., for damage to an unattended vehicle. Officers learned the owner of the vehicle realized at some point this date an unknown vehicle had struck the passenger side front bumper of her vehicle and failed to stop.

Officers arrived to learn a 42 year old male traveling on Conneaut Lake Road and had struck a deer causing damage to the vehicle. No injuries occurred as a result of the crash.

**Miscellaneous.** Officers responded to assist fire, EMS, and citizens on 31 occasions and answered 2 alarm calls. Patrol officers conducted 13 traffic stops resulting in 7 traffic citations being issued.
