Week of November 10, 2019

Sunday November 10

At 4:23 p.m. officers were dispatched to the Shell Gas Station State Highway 18, Sadsbury Twp., for the report of trespass. Officers learned that a 50 year old male was on the property earlier after having been warned not to return.

At 7:46 p.m. officers were dispatched to a residence in the 11000 block of Morningshores Drive, Sadsbury Twp., for the report of a behavioral disorder. The juvenile requested to be transported for medical care and officers transported her for the care.

Monday November 11

At 9:32 a.m. officers were dispatched to a residence in the 1600 block of Crom Road, N. Shenango Twp., for the report of a domestic argument. It was learned that a 55 year old male was involved in an ongoing argument with his 30 year old daughter. The daughter assaulted the father and officers arrested the daughter and placed her in the county jail.

At 10:45 a.m. officers were dispatched to South 4th Street and Strawberry Alley, Conneaut Lake Borough, for the report of theft. A catalytic convertor was stolen from a parked vehicle.

At 11:00 a.m. officers were dispatched to a residence in the 12000 block of Sylvia Drive, N. Shenango Twp., for the report of a trespass. It was reported by a neighbor that someone forced entry to a shed on the property and it was unknown at the time of report if anything had been taken.

At 2:00 p.m. officers were contacted at the station by an Ohio male reporting harassment. The male reported being harassed by a female from the Conneaut Lake area after he broke off an internet relationship. It was later determined the female resided in Summit Twp., and the incident was turned over to PA State Police.

At 9:19 p.m. officers attempted to initiate a traffic stop on a vehicle near 1st Street and Water Street, Conneaut Lake Borough. The operator fled from the officer and a short pursuit occurred. The officer terminated the pursuit at the Sadsbury Twp. line due to weather conditions. Charges were eventually filed against the known operator.

Tuesday November 12

At 4:47 p.m. officers were dispatched to the area of State Highway 285 and W. Townline, Sadsbury Twp., for the report of multiple motor vehicles stuck on the snow covered roadway. While conducting traffic control for PennDot it was learned that one vehicle rear-ended another causing minor damage.

At 5:46 p.m. officers were dispatched to Water Street and North 2nd Street, Conneaut Lake Borough, for the report of a motor vehicle crash. James Morohovich, 82, Conneaut Lake, reported that as he was approaching the intersection and unknown white vehicle entered his path causing him to brake sharply

and slide on the snow covered road. The vehicle slid into the traffic light utility pole. The vehicle required towing and no injuries were reported.

At 6:03 p.m. officers were dispatched to the Sheetz on Water Street, Conneaut Lake Borough, for the report of a motor vehicle crash. After a search of the area officers were unable to locate any vehicles involved in a crash.

At 6:43 p.m. officers were dispatched to the area of Church Road and Seneca Road, N. Shenango Twp., for the report of a motor vehicle crash. Officers and the VFD assisted with removing the vehicle from a ditch and no damage or injuries were reported.

Wednesday November 13

At 6:08 a.m. officers were dispatched to the 8900 block of US Highway 6, Sadsbury Twp., for the report of a motor vehicle crash. It was learned that Jude Pardee, 20, Linesville was travelling on the roadway when his vehicle struck a deer causing him to lose control of the vehicle. The vehicle entered the yard of a residence striking garden boxes narrowly missing a main natural gas line. There were no reported injuries and the vehicle was towed from the scene.

At 8:05 a.m. officers were dispatched to South 3rd Street and Richmond Street, Conneaut Lake Borough, for the report of a motor vehicle crash. It was reported that a semi-truck struck a tree. Officers were unable to locate any vehicles or crash scene.

At 8:33 a.m. officers were dispatched to a residence in the 3800 block of Bentley Road, N. Shenango Twp., for the report of repeated 911 hang up calls. A male was located and reported cellular phone issues and that he was enroute to his service provider as the phone kept calling 911.

At 8:48 a.m. officers were dispatched to Fireman's Beach, Sadsbury Twp., for the report of a theft. It was reported that an unknown person cut the fuel line to a marine fuel tank and removed the fuel tank.

At 8:22 p.m. officers were dispatched to Cochranon road, W. Mead Twp., to assist W. Mead Police with an overdose in the roadway.

Thursday November 14

At 6:03 a.m. officers were dispatched to the 11000 block of State Highway 285, Sadsbury Twp., for a report of a motor vehicle crash. It was learned that Patrick Duffy, 61, Conneaut Lake failed to negotiate a curve in the roadway causing the vehicle to leave the roadway and strike multiple trees. There were no reported injuries and the vehicle required towing.

At 9:30 a.m. officers were dispatched to a residence in the 10000 block of Old State Road, Sadsbury Twp., for the report of a stolen motor vehicle. Officers determined that the stolen vehicle was the same vehicle involved in a short pursuit on the prior Monday.

At 11:09 p.m. officers were dispatched to the area of State Highway 285 and Canal Road, Sadsbury Twp., for the report of a child walking in the middle of the roadway. Just prior to police arrival it was reported that a male in a dark colored vehicle picked the child up and identified himself as the child's father. Officers stopped multiple dark colored vehicles in the area over a period of time but were unable to locate the child.

Saturday November 16

Troopers located a trailer on a property outside Linesville and requested officers attempt to locate the registered owner. Officers learned the trailer was stolen and additionally contained two snowmobiles. The snowmobiles were reported stolen and the trailer returned to the owner.

At 4:23 p.m. officers were dispatched to a residence in the 1600 block of Crom Road, N. Shenango Twp., for the report of a disturbance. It was learned that an adult was yelling at children for behavioral issues.

At 7:15 p.m. patrol officers located a disabled vehicle in the 9600 block of US Highway 6, Sadsbury Twp., after the lug nuts fell off the vehicle rim.

At 10:08 p.m. officers were dispatched to the 300 block of High Street, Conneaut Lake Borough, for the request to search a residence. The landlord felt a past tenant forcibly entered the residence unlawfully. Nothing was located.
