

## **Conneaut Lake Regional Police**

### **Weekly Police Blotter**

#### **Week of November 24, 2019**

##### **Sunday November 24**

At 12:30 a.m. patrol officers located a suspicious vehicle near the intersection of State highway 285 and Hartstown Road, N. Shenango Twp. Officers spoke with the sleeping operator and all was determined to be okay.

At 5:13 a.m. officers were dispatched to Comstock Street and Utley Street, Sadsbury Twp., for the report of two suspicious males. After a search of the area, officers were unable to locate the males.

At 8:53 a.m. officers were dispatched to the 2200 block of Hazel Avenue, N. Shenango Twp., for the report of a suspicious vehicle. Officers determined the operator was hanging a tree stand in a wooded area.

At 2:20 p.m. patrol officers located a heater alongside the roadway on Linn Road and Lillian Road, N. Shenango Twp. The item was placed in lost and found at the police station.

At 3:56 p.m. officers were dispatched to Rite Aid, South 3<sup>rd</sup> Street, Conneaut Lake Borough, for the report of retail theft. It was learned that two male juveniles entered the store at around 3pm and removed magic cards and Magnavox wireless headphones without paying for the items.

At 6:59 p.m. officers were dispatched to a residence in the 12000 block of West Vernon Road, Sadsbury Twp., for a child custody issue. The issue was temporarily worked out until CYS could assess the issues as the family was already involved with the agency.

##### **Monday November 25**

At 12:55 a.m. patrol officers located a suspicious vehicle in the 2400 block of Penn Street, N. Shenango Twp. Officers identified the two male occupants and all was determined to be okay.

At 8:00 a.m. officers were notified of a very minor motor vehicle crash in the driveway drop off area of Conneaut Lake Middle School, US Highway 6, Sadsbury Twp. A bus and passenger vehicle struck mirrors and information had already been exchanged between the parties.

At 3:15 p.m. officers were dispatched to US Highway 322 and W. Townline Road, Sadsbury Twp., for the report of a motor vehicle crash. Nicole Moore, 35, Greenville reported that while travelling west on the highway a deer entered the road causing her to swerve. The vehicle left the roadway and struck a street

sign at the intersection. The operator reported minor injuries and refused medical treatment. The vehicle was towed by a family member.

### **Tuesday November 26**

At 8:55 a.m. officers were dispatched to a residence in the 12000 block of W. Vernon Road, Sadsbury Twp., for the report of a child custody issue and a behavioral disorder. After intervention all was temporarily taken care of and parties separated.

At 11:42 a.m. officers were dispatched to a residence in the 12000 block of W. Vernon Road, Sadsbury Twp., to assist Crisis Intervention. A subject was taken into custody without incident for a mental health warrant and transported to the hospital for assistance.

At 12:18 p.m. officers were dispatched to a residence in the 1700 block of Stuart Drive, N. Shenango Twp., for an attempted burglary report. Unknown person(s) attempted to pry open a door to the residence and a shed door without gaining entry.

At 6:45 p.m. officers were dispatched to Lakeside Bowling Lanes, State highway 18, Sadsbury Twp., for a report of trespass. The owner reported a homeless male on the property that initially failed to leave. The male was gone upon police arrival but officers knew the male and later located him issuing a trespass notice.

At 8:50 p.m. officers were dispatched to US Highway 6, Sadsbury Twp., on a report from Linesville Police of a possible drunk driver. Officers were unable to locate the vehicle.

### **Wednesday November 27**

### **Thursday November 28**

The male (patron) was located, detained and transported to the barracks for questioning.

A male reported that his dogs were wandering the neighborhood and a person reported another neighbor shooting the dogs with a BB gun. Officers were unable to locate any injuries to the dogs nor anyone to verify that the dogs were being shot at. The dog owner was not pleased with the outcome and became angered at officers. He was then issued a verbal warning for the dog restraint ordinance in the township.

At 3:34 p.m. officers were dispatched to the 9600 block of Stillwater Trail, N. Shenango Twp., for the report of persons shooting guns into a pond creating a hazard. Officers spoke with multiple complainants who could not identify the involved persons. Officers patrolled the area and were unable to locate anyone shooting.
