#### Sunday December 1

#### Monday December 2

The caller reported being struck by a vehicle in the intersection that fled east on Water Street and Conneaut lake Road. The vehicle was located by Pa State Troopers on Conneaut Lake road in Vernon Twp. Upon attempting to initiate a traffic stop, the vehicle left the roadway and struck signs near the intersection of State Highway 19. Troopers arrested the male operator for suspicion of DUI.

At 7:05 a.m. officers were dispatched to Aldina Drive near Kirilla Lane, Sadsbury Twp., for the report of an injured deer in the roadway. Officers located and dispatched the deer.
