Sunday January 05

Upon impact of the vehicles, Notartianni lost control of his vehicle at which time it impacted utility poles. VFD personnel extricated Notartianni from the vehicle by mechanical means and he was transported for medical care. Charges are pending.

The caller reported a male harassed her children via a voicemail message. The officer called the number and spoke with the juvenile male's grandmother and after advising of the harassing nature of the call assured officers and parents that the activities would cease.
