

## **Conneaut Lake Regional Police**

### **Weekly Police Blotter**

#### **Week of January 19, 2020**

##### **Sunday January 19**

At 12:37 a.m. patrol officers observed a suspicious vehicle parked at a business in the 12000 block of Conneaut Lake Road, Sadsbury Twp. Officers identified the occupants from Greenville PA, issued a trespass warning and removed them from the property.

At 12:30 p.m. officers were dispatched to US Highway 6 and Brooks Road, Sadsbury Twp., for the report of road debris. Officers were unable to locate any road debris.

At 3:56 p.m. officers were dispatched to a residence in the 11000 block of Midway Drive, Sadsbury Twp., for the report of criminal trespass. Unknown persons forced entry to a property however nothing was known to be missing.

At 7:51 p.m. officers were dispatched to Duff Drive and Reigleman Drive, N. Shenango Twp., for the report of a suspicious vehicle. Officers were advised while enroute that the black Mustang had left the area and officers were not able to locate the vehicle upon a search of the area.

### **Thursday January 23**

It was reported that a child observed a male standing outside watching through a window. Officers were unable to locate any signs of anyone walking or standing in the snow.

At 2:34 p.m. officers were dispatched to an apartment in the 11000 block of State Highway 18, Sadsbury Twp., to assist sheriff's deputies with executing an arrest warrant. A 32 year old male was taken into custody and placed in the county jail.

### **Friday January 24**

### **Saturday January 25**

It was reported that an unknown female was running and screaming for help in the area. A patrol unit was near the intersection at the time of the call, didn't hear anything and searched the area extensively and was unable to locate anything.

At 1:36 p.m. officers were dispatched to Water Street and 3<sup>rd</sup> Street, Conneaut Lake Borough, for the report of a hit and run crash. It was learned that a vehicle failed to stop for a steady red traffic signal and struck another vehicle in the intersection leaving the area prior to exchanging information or awaiting police arrival. Officers located the license plate of the striking vehicle at the crash scene and a locate was issued as well as contact with Vienna Ohio police. Vienna police located the vehicle, initiated a traffic stop and detained the subject for all pertinent information. Charges were filed against the operator.

At 6:15 p.m. officers were dispatched to Jerry's Bar, Linesville Borough, to assist Linesville Police with a disturbance.

**Miscellaneous.** Officers responded to assist fire, EMS, and citizens on 7 occasions and answered 0 alarm calls. Patrol officers conducted 4 traffic stops resulting in 1 traffic citation being issued.
