Sunday January 26

At 1:26 a.m. patrol officers observed a suspicious male pacing in the alley on Strawberry Alley at South 5th Street, Conneaut Lake Borough. Officers identified the male and learned he was walking off a medical issue and refused medical transport.

At 2:41 a.m. officers were dispatched to Aces Bar, State Highway 18, Sadsbury Twp., for the report of a large fight in progress. Officers were unable to locate any persons upon arrival and it was learned that when the bartender announced that the police were on the way everyone fled.

At 12:50 p.m. officers were dispatched to a residence in the 9900 block of Espy Road, N. Shenango Twp., for a 911 call check. Officers were unable to locate anyone at the residence.

Monday January 27
