Sunday February 2

At 6:00 p.m. officers were contacted by a male reporting that he struck an unknown small animal in the roadway on State Highway 618 near McClure Street, Sadsbury Twp. and requested officers attempt to locate the animal and render aid if needed. Officers were unable to locate anything.
