Sunday February 9

At 12:00 a.m. officers were dispatched to the Hotel Conneaut, Lake Street, Sadsbury Twp., for the report of multiple people fighting in the lobby. Upon arrival of officers it was learned that the fight stopped and management only wanted assistance to remove one intoxicated male.

At 2:16 p.m. officers were dispatched to a business in the 200 block of Water Street, Conneaut Lake Borough, for the report of suspicious activity. The caller reported an unknown male placed something in the main door to the business. Officers determined the item was a business card.

At 6:23 p.m. officers were dispatched to Brown Avenue and Comstock Street, Sadsbury Twp., for the report of reckless driving. Officers located the driver and determined that the driver was swerving to avoid a pot hole at the same time a child ran into the street from behind a tree.

Monday February 10

At 2:13 p.m. officers assisted a PA State Constable at a residence in the 12000 block of Reed Avenue, Summit Twp., to execute an arrest warrant from charges initially filed by the department. No contact was made.

Tuesday February 11

The vehicle was followed by the caller into Greenwood Twp., and the caller was transferred to PA State Police by the dispatch center. It is unknown if the vehicle was located.

Saturday February 15

It was learned that a family member located the 35 year old male partially in the garage and partially outside deceased. The investigation is pending the coroner's report.

At 10:25 a.m. officers were dispatched to a residence in the 12000 block of Teifer Avenue, Sadsbury Twp., for the report of a burglary. It was learned that unknown persons forced entry into the residence and removed \$50 worth of property.

At 2:24 p.m. officers were dispatched to the US Post Office, North 4th Street, Conneaut Lake Borough, for the report of a motor vehicle crash. It was learned that Nancy D. Martin, 68, Conneaut Lake entered the parking lot when her foot became lodged between the gas and brake pedal causing the vehicle to strike the building. There were no reported injuries and the vehicle was driven from the scene.

At 5:33 p.m. officers were dispatched to Hartstown Road south of State Highway 285, N. Shenango Twp., initially for a motor vehicle crash. While enroute it was learned that a motorist pulled to the side of the road for a medical emergency and passersby were performing CPR. The motorist was transported by EMS personnel.

At 7:22 p.m. officers located a disabled motorist on US Highway 6 near Free Road, Sadsbury Twp. A short time later another motorist provided fuel to the operator of the disabled vehicle and the vehicle left the area.

<u>Miscellaneous.</u> Officers responded to assist fire, EMS, and citizens on 3 occasions and answered 2 alarm calls. Patrol officers conducted 1 traffic stop resulting in 2 traffic citations being issued.
