

## **Conneaut Lake Regional Police**

### **Weekly Police Blotter**

#### **Week of February 23, 2020**

##### **Sunday February 23**

At 3:14 a.m. patrol officers located a male acting suspiciously in the 300 block of Water Street, Conneaut Lake Borough, while the male was in a parked vehicle. Officers learned that the male was wanted for an outstanding misdemeanor warrant from Mercer County. The 33 year old Linesville male was taken into custody and transported to the county jail for the warrant. A citation for disorderly conduct was also filed against the male.

### **Friday February 28**

At 6:56 a.m. officers were dispatched to a residence in the 9700 block of Third Street, N. Shenango Twp., after agents from the Western PA Fugitive Task Force entered a residence to execute an arrest warrant and discovered possible methamphetamine manufacturing. Officers obtained a search warrant and with assistance of the CLAN team searched the property recovering and securing multiple items involved in the process to include a large quantity of methamphetamine. The task force removed a male and female from the property and charges are pending.

#### **Saturday February 29**

At 1:06 p.m. officers were dispatched to Water Street and 9<sup>th</sup> Street, Conneaut Lake Borough, for the report of 3 dogs in the street. The owner was located at the same time officers arrived and the dogs were retrieved by the owner.
