### **Weekly Police Blotter**

#### **Week of March 01, 2020**

##### **Sunday March 01**

At 3:46 a.m. patrol officers located a suspicious vehicle near the intersection of US Highway 6 and Free Road, Sadsbury Twp. After identifying the male and female occupant all was determined to be okay.

##### **Monday March 02**

At 7:10 a.m. officers were dispatched to a residence in the 10000 block of McClure Street, Sadsbury Twp., for the report of trespass. It was learned that the property owner called in for juveniles standing under a pine tree to avoid the rain while awaiting the school bus that refused to move off the property.

At 6:19 p.m. officers were dispatched to the 18000 block of Conneaut Lake Road, Vernon Twp., to assist Vernon PD with a double overdose.

At 8:20 p.m. officers were dispatched to a residence in the 500 block of High Street, Conneaut Lake Borough, for an animal complaint. The caller reported a deceased cat in her yard and suspected poisoning demanding that officers remove the cat and test it for poisoning. The caller was referred to humane society officers to have that done. The caller became irate and began yelling vulgarities at the officers at which time they cleared the call.

At 9:52 p.m. officers were dispatched to a residence in the 16000 block of Cussewago Road, Vernon Twp., to assist Vernon Police with a burglary in progress.

##### **Tuesday March 03**

At 8:00 p.m. officers were dispatched to a residence in the 1600 block of Pine Road, N. Shenango Twp., to assist PA State Police locate a vehicle involved in a hit and run crash of a pedestrian at Ray's Marketplace in Pine Twp.

At 8:38 p.m. patrol officers located a disabled vehicle along State Highway 285 near S. Canal Road, Sadsbury Twp. It was learned the operator had already contacted a tow truck and officers waited until the truck arrived.

At 9:00 p.m. officers were dispatched to a residence in the 9700 block of Canoe Trail, N. Shenango Twp., for the report of loud noise. It was learned that the caller was upset about a neighbor's generator running all the time. Officers determined that the generator was the main power source for the residence.

At 11:05 p.m. officers were dispatched to a residence in the 300 block of High Street, Conneaut Lake Borough, at the request of Meadville City Police to attempt to locate a suspect involved in a shooting in the city. Officers located and detained the subject near State Street and 5<sup>th</sup> Street, who was eventually released to Meadville Police Detectives for arrest.

### **Wednesday March 04**

At 3:39 p.m. officers were dispatched to a residence in the 800 block of State Street, Conneaut Lake Borough, to assist Meadville City Police conduct a follow up investigation.

At 6:49 p.m. officers were dispatched to a residence in the 12000 block of Monnie Avenue, Sadsbury Twp., for the report of a burglary. Unknown person(s) forced entry into the residence and it was unknown if anything was missing from the residence at the time of report.

At 6:59 p.m. officers were dispatched to the 1500 block of Shaker Road, N. Shenango Twp., for the report of a loose dog. Officers took custody of the dog after the owner was unable to be contacted. The owner called the department earlier in the day to report the dog missing. The owner was eventually contacted in S. Shenango Twp. and the dog returned by officers.

At 9:48 p.m. officers were dispatched to a residence in the 200 block of Bunday Street, Linesville Borough, to assist Linesville Police with a reported domestic argument.

### **Thursday March 05**

At 12:25 a.m. officers were dispatched to State Highway 18 and Oakmont Road, Sadsbury Twp., to check the welfare of PA State Troopers on a traffic stop. Officers made contact and confirmed the Troopers were okay.

At 1:15 a.m. officers were dispatched to Linesville Borough to check the status of a Linesville Officer after repeated attempts on status checks failed. Officers located the Linesville Officer and all was okay.

At 3:36 p.m. officers were dispatched to a property in the 7700 block of State Highway 285, Sadsbury Twp., for the report of trespass. The caller reported a neighbor trespassing on property. Upon contact with the neighbor they reported the original caller was peeping in their windows.

At 11:49 p.m. patrol officers located a large plume of smoke and upon investigation observed a large fire of burning construction materials behind a residence in the 12000 block of W. Vernon Road, Sadsbury Twp. It was determined the fire was in violation of township ordinance and the property owner had been warned and cited in the past for the same violation. The property owner put the fire out and a citation was filed for the violation.

### **Friday March 06**

At 1:53 a.m. officers were dispatched to the area of Hanmore Road and Greiser Road, Sadsbury Twp., at the request of N. Strabane Twp. Police to attempt to locate a male subject that was suicidal. A cellular ping of the phone placed the male in that area. Officers were unable to locate the male and a second ping placed the male in the area of Meadville Airport. It was later learned that family members located the male at Hotel Conneaut and transported him for medical care.

At 5:13 p.m. officers were dispatched to the 3100 block of State Highway 285, N. Shenango Twp., for suspicious activity. The caller reported that while driving by a residence a white older male was pointing at his vehicle in the shape of a fake firearm as if pretending to shoot at his vehicle. Officers didn't locate the elderly male.

At 6:57 p.m. officers received a phone call from a male reporting he wanted a local pizza shop arrested for theft. He received cold pizza and felt the police should arrest the employees. He was referred to the manager of the pizza shop.

At 10:23 p.m. patrol officers located a suspicious male at Crom Road and Espy Road, N. Shenango Twp., wearing black, carrying a duffle bag walking in the neighborhood. Upon an officer exiting the patrol unit the male fled on foot. After a short foot chase, the officer was unable to locate the male in the heavy snowfall. Officers were assisted by Linesville Police.

**Saturday March 07**

At 10:44 p.m. officers were dispatched to a residence in the 10000 block of Sunset Avenue, Sadsbury Twp., for the report of an intoxicated male. It was learned that the children contacted police as both parents were intoxicated and arguing over alleged extra marital affairs. The parties were separated for the evening.

**Miscellaneous.** Officers responded to assist fire, EMS, and citizens on 3 occasions and answered 2 alarm calls. Patrol officers conducted 3 traffic stops resulting in 1 traffic citation being issued.
