Sunday March 29

At 12:50 a.m. officers were dispatched to a residence in the 600 block of Water Street, Conneaut Lake Borough, for the report of loud music. Officers located the residence with the loud music and a citation was filed for disturbing the peace as this resident had been warned multiple times and cited once in the past.

At 5:00 a.m. patrol officers located and assisted the road department with multiple flooded roadways in Sadsbury Twp.

At 9:11 a.m. officers were dispatched to a residence in the 1700 block of Alden Lane, N. Shenango Twp., for the report of an overdose. It was learned that an 18 year old male overdosed on multiple substances and was transported to the hospital for further treatment.
