Week of April 12, 2020

Sunday April 12

At 12:41 a.m. officers were dispatched to an apartment building in the 100 block of High Street, Conneaut Lake Borough, for the report of a loud party. Officers contacted the apartment renter and a verbal warning was issued for the noise.

At 12:55 a.m. officers were dispatched to a residence in the 300 block of High Street, Conneaut Lake Borough, for the report of harassment. It was learned that a known male sent a social media message to the caller which she felt was harassing.

At 2:12 p.m. officers were dispatched to the 14000 block of W. Vernon Road, Vernon Twp., to assist Vernon Police with a call regarding multiple 911 call hang ups.

At 9:42 p.m. officers were dispatched to the 1800 block of State Highway 285, N. Shenango Twp., for the report of a gunshot victim. It was learned that a 24 year old male was attempting to disassemble a handgun when the firearm discharged striking him in the hand and leg. The male was flown by medical helicopter to Youngstown for medical treatment.

At 10:53 p.m. officers were dispatched to an apartment building in the 100 block of South 4th Street, Conneaut Lake Borough, for an unknown disturbance. It was learned that a child was having a temper issue.

It was determined that a squirrel bit through a high tension power line disrupting power to the area. A Penn Power Company supervisor arrived a short time later and the issue was taken care of.
