### **Weekly Police Blotter**

#### **Week of April 19, 2020**

##### **Sunday April 19**

At 12:19 p.m. officers were dispatched to the 500 block of Water Street, Conneaut Lake Borough, for the report of a loose Beagle. Officers were unable to locate the dog.
