### **Weekly Police Blotter**

#### **Week of July 12, 2020**

##### **Sunday July 12**

At 12:19 a.m. officers were dispatched to a residence in the 9300 block of US Highway 6, Sadsbury Twp., for the report of ATV's on the roadway. Officers located a large party and warned the property owner of the violations.
