### **Weekly Police Blotter**

#### **Week of October 18, 2020**

##### **Sunday October 18**

At 12:30 p.m. officers were dispatched to a residence in the 12000 block of Allen Road, Sadsbury Twp., for the report of a 911 call check. The subject dialed the wrong number.

At 5:00 p.m. officers were dispatched to the 9700 block of George Street, N. Shenango Twp., for the report of a found dog. Upon arrival the owner was located.

At 9:05 p.m. officers were dispatched to the 11000 block of Campbell Road, Sadsbury Twp., for the report of a reckless driver. The caller reported that earlier in the day he was nearly struck by a purple colored Volkswagen Jetta while raking leaves along the roadway.
